Requisite eligibilities of the Agency/ Firm

Eligibility Criteria & Conditions -

- The agency should be registered under VAT and Income Tax. The agency should file returns for last 3 years.
- The agency should have experience of working in the relevant area for a minimum of 3 years as on 31st March, 2017.
- The agency must not be blacklisted by State/Central Govt. Deptt. or anyother govt. bodies. An affidavit to this effect shall be furnished by the bidder with the bid document.
- The agency should not have been penalized for delay in completion of work. 4
- The contract may be terminated with one month notice subject to delay/ unsatisfactory performance in the work. In such case the work shall be allotted to next suitable bidder after deducting the cost/expense from the former one.
- Contract document with the successful bidder shall be executed within 21 days of the issue of the letter of acceptance. Non fulfilment of this condition of executing a contract

- by the contractor or supplier would constitute sufficient ground for annulment of the award and forfeiture of Earnest Money Deposit.
- 7. BSDMA has right to reject the supply of goods which do not conform to the specification.
- 8. BSDMA shall penalize @Rs. 500/- per day on any lapses in service.
- 9. Applicant shall submit financial proposal in a sealed envelope clearing indicating its name and contact details with address phone Mo. and E-mail ID.

10.Bid security: The bid security of Rs 5,000/- shall be accepted in the form of Account Payee Demand Draft/ Fixed Deposit Receipt/Banker's Cheque or Bank Guarantee from any of the Notionalised banks payable to Secretary, BSDMA in an acceptable form. Bid security of the unsuccessful bidders shall be returned to them after expiry of the final bid validity latest on or before the 30th day after the award of the contract.
